3. The quoted price should be inclusive of all applicable taxes.
4. a) The bidders have to submit Cash or D.D drawn in favour of Honorary Secretary, Indian Red Cross Society, Odisha State Branch payable at Bhubaneswar towards cost of Tender Paper of Rs.2,000/- (non-refundable) & Earnest Money Deposit (EMD), which should be equal to 2% (non-interest bearing) of the total quoted value.
